In accordance with the university's instructions:

- 1. The student who takes the English Aptitude exam and gets the mark:
- 84% or above, is exempt from studying the English remedial course (0202099) and is equivalent to the English language course (0202101) by the word "pass".
- 50% to 83.9%, is exempt from studying the English remedial course (0202099) and must study the English course (0202101).
- Less than **50%** (**fail**), must study the English remedial course **(0202099)** as a prerequisite for English language course **(0202101)**.
- 1. The student who takes the Arabic Language Aptitude Test and receives the mark:
- 84% or above, is exempt from studying the Arabic remedial course (0201099) and equivalent to the Arabic language course (0201101) by the word "pass".
- 50% to 83. 9%, is exempt from studying the Arabic language remedial course (0201099) and must study the Arabic language course (0201101).
- Less than **50%** (fail), must study the Arabic remedial course (**0201099**) as a prerequisite for Arabic language course (**0201101**).
- 1. The student who takes the computer aptitude test and gets the mark:
- 50% or more (pass), is exempt from studying the computer remedial course (0612099).
- Less than 50% (fail), must study the computer remedial course (0612099).

1. The military science course is compulsory for Jordanian students only. Students of other nationalities do not need to study this course. Students who have graduated from the Royal Military College and equivalent institutes are exempted from studying this course.

Course Description

| 3 credit hours | Entrance to Law Science | 1408101 |

This course examines the formation and definition of the law, its objectives and functions, its importance to society, the distinction between it and other norms of social science, the statement of the law's sections, branches and sources of law (such as legislation, custom, rules of Islamic jurisprudence, principles of Islamic sharia and jurisprudence), the application and interpretation of the law, and its repeal; It also addresses the right, in terms of definition, types and division of rights, persons, scope, sources, use and evidence of the right, and how to protect it.

This course deals with the study of the general theory of the sources and division of the commitment and the definition of the origin and sources of the obligation, where it deals with the voluntary sources of contract and individual will, and the involuntary sources: injurious act, beneficial act, and law.

This course deals with so-called contracts in the Civil Code, by defining it, identifying its legal characteristics, its pillars, effects, detailed study for sale and rent contracts and other types of sales provided for by law, and the lease contract in terms of its definition, elements, provisions, effects and termination, and then addresses the applications of the Owners and Tenants Act.

This course deals with the explanation of the provisions of the Labor Code and the Social Security Act. In section I, the examination of the Labor Code in terms of its sources, the contract of individual employment, established by its parties, of the rights and obligations of the worker and the employer of occupational injury, occupational illnesses, termination of the contract, the contract of collective action, its provisions, and all related matters. Section II examines the Social Security Act and examines it in terms of indicating the public assets of social security systems, determining the scope of the Act's application, and examining the social insurance covered by it.

This course addresses the emergence and evolution of commercial law and the distinction between business and civil work in terms of distinctions between them and the criteria for differentiation between each other's acts. And the study of land-based businesses by virtue of their subjectivity and subsidiary business, maritime business, the merchant's requirements and duties to register in the commercial registry, Keeping business books, taking a business address and refraining from unlawful competition commercial contracts, commercial mortgage, commission, brokerage and contract of carriage.

This course deals with selected subjects of civil law, such as some recent contracts of interest like agreement contract, proxy contract, certain subjects relating to civil liability, liability, contract, and special subjects relating thereto.

This course deals with the formation of companies, the concept and types of company, the distinction between commercial companies and civil companies, the provisions and legal pillars relating to their formation and the provisions on the liquidation and expiry of companies in general Company of Solidarity, Simple Recommendation Company, Scissors Company and Liability Company Limited Equity Recommendation Company, Private Shareholding Company, Public Shareholding Company, and legal provisions relating to each of these companies in addition to foreign companies, holding companies, exempt companies, and addressing the subject of commercial bankruptcy, bankruptcy-protective correction and related legal provisions.

This course deals with the legal provisions of all commercial papers regulated by the Trade Law (withdrawal bond, order bond, cheque) in terms of their functions and the legal provisions of each paper. It also deals with the most important banking transactions such as deposit, current account, financial credit, documentary credit and letter of guarantee.

This course deals with the study of the legal provisions governing electronic commerce at the domestic and international levels, the Jordanian Electronic Transactions Act and the UNESTRAL Model Law in particular. The textbook's vocabulary includes the definition and indication of the relevance of electronic commerce, the legal problems arising therefrom and the proposed solutions thereto, such as those relating to electronic contracting, electronic signature, consumer protection in electronic commerce, means of fulfilment in electronic commerce, applicable law in electronic commerce and means of resolving disputes arising therefrom.
